To: All Prospective Offerors

The above numbered and described solicitation is amended as set forth below:

1.1 Scope of Work, Section II, A.1, Page 15 of 101:

Correction: Number of eligible consumers, therefore, the first paragraph shall now read:

“This request for a proposal ensures appropriate housing options with 24 hour supervision for five (5) eligible consumers with severe/serious mental illness. Consumers referred to this program have been identified to be medically stable but unable to live independently in the community even with family supports and GBHWC intensive outpatient services.”

1.2 Scope of Work, Section II, C. h), Page 16 of 101:

Correction: To correct and replace the word “dissipate to “participate, therefore, h) shall now read:

“*Recreation leisure and spiritual activities:* daily programming and staff support to assist consumers to identify recreational and community-based leisure activities to include spiritual activities in accordance with their individual and religious release and preferences;”

1.3 Scope of Work, Section II, L.5, Page 24 of 101:

Correction: To delete “GBHWC form” with “reporting format”, therefore, L.5 shall now read:


“Offeror will determine the reporting format to document consumer’s financial information that describes a consumer’s availability of funds from any source that may provide for housing, nourishment, and money to be spent for the consumer’s needs. The report will be submitted monthly as an attachment to the monthly invoices for payment of services.

1.4 Evaluation Criteria, Section IV.C, Page 32 of 101:

Addition: To add words to complete sentence, therefore, the fourth (4th) evaluation criteria shall now read:

"Current, certified financial statement or latest financial audit (within 1 to 3 years). Offeror must have sufficient working capital and not rely on the compensation for the first year of the contract."

Except as provided herein, all terms and conditions of the document referenced in the solicitation number above remain unchanged and in full force and effect.
