The above numbered and described solicitation is amended as set forth below:

1.1 Section II.D.8, Scope of Work, Phase I, Support Services, Page 20 of 142:

Correction: To correct and replace the word "dissipate to "participate", therefore, D.8 shall now read:

"Recreation leisure and spiritual activities: Daily programming and staff support to assist consumers to identify and to participate in community-based leisure activities to include spiritual activities in accordance with their individual and religious beliefs and preferences."

1.2 Section II.L.5, Scope of Work, Page 28 of 142:

Correction: To delete whole paragraph and replace it with a new paragraph; therefore, L.5 shall now read:

"Offeror will determine the reporting format to document consumer's financial information that describes a consumer's availability of funds from any source that may provide for housing, nourishment, and money to be spent for the consumer's needs. The report will be submitted monthly as an attachment to the monthly invoices for payment of services."

1.3 Section IV.B.3 Proposed Contents, Requirements and Instructions, Page 36 of 101:

Correction: To correct and eliminate the requirement for certification of substance treatment counselors; therefore, the whole paragraph of Item 3 shall now read:

The GBHWC also requires respondents to present satisfactory evidence that the consultancy and personnel have sufficient experience and are qualified to provide these services. Entities submitting proposal must be able to demonstrate in detail their stability in the communities to provide Level II residential, therapeutic and support services for adults serious/severe mental illness with or without co-occurring intellectual disabilities. The proposal must include <u>current</u> resumes of treatment staff with experience and expertise in treatment and <u>must identify a lead current treatment</u> <u>specialist or clinical supervisor</u> that would be responsible for treatment outcomes and contractual performance. The following list the minimum qualifications for treatment staff with a least one member as the Lead Treatment Specialist.

- Lead treatment specialist or clinical supervisor must have a Master's degree in any psychology, social work, counseling or related fields;
- b. Care worker staff must have high school diploma (or GED), valid driver's license and training in recovery models, behavioral health, etc. (will commence upon hire).

Except as provided herein, all terms and conditions of the document referenced in the solicitation number above remain unchanged and in full force and effect.
