The Guam Behavioral Health and Wellness Center (GBHWC) is inviting qualified organizations/individuals to provide services as **State Epidemiological Outcomes Workgroup (SEOW) Lead Epidemiologist**, to fulfill the goals of the Strategic Prevention Framework - Partnerships for Success (SPF-PFS) Grant: to address underage drinking and tobacco/nicotine use among youth ages 9 to 20. This grant program will be managed by GBHWC's Prevention and Training Branch's whose mission is "to establish and implement culturally appropriate and sustainable prevention and early intervention policies, programs and practices that are responsive to the needs of the people of Guam and that are proven to effect positive behavioral health changes."
