The above referenced solicitation is hereby clarified:

 "Do we need to do a Needs Assessment Report and Community Action Plan prior to the implementation approved by the PEACE Council before the submission of the application?"

Answer: As noted in Section III. BACKGROUND AND SERVICES REQUIRED, pages 8 of the RFP, 'RFP applicants are required to submit a Needs Assessment Report and a Community Action Plan (CAP)'. Submission of these documents is further noted as part of CONTRACTOR QUALIFICATIONS in Section III. BACKGROUND AND SERVICES REQUIRED, pages 9-10 of the RFP. PFS funding awards will provide support for completion of all PFS steps as reflected in Section III. BACKGROUND AND SERVICES REQUIRED, pages 8-10 of the RFP, to include the strengthening and updating of the organization's Needs Assessment Report and/or Community Action Plan that may need to be further developed in order to be endorsed by PEACE (as noted in Section I. PUBLIC NOTICE, page 4 of the RFP) for full implementation and evaluation.

2. "Is there are ceiling and/or floor for funding?"

Answer: Offeror must submit an annual budget proposal (for each of the 3 years), which describes 'justifiable expenditures that will support the accomplishment of the objectives of Guam's PEACE PFS project and the work described in the Scope of Work and documented in the Applicant's Community Action Plan' (Section IV. PROPOSAL PROVISIONS, page 15 of the RFP).

3. "Would they [sic] PEACE Council be meeting prior to the deadline of September 25, 2015 to approve any additional plans from prospective applicants?"

Answer: No, the PEACE Council will not meet prior to the deadline of September 25, 2015. The PEACE Council is not required to approve an organization's Needs Assessment Report or Community Action Plan prior to its submission in response to this RFP. PFS funding awards will provide support for completion of all PFS steps as reflected in Section III. BACKGROUND AND SERVICES REQUIRED, pages 8-10 of the RFP, to include the strengthening and updating of the organization's Needs Assessment Report and/or Community Action Plan that may need to be further developed in order to be endorsed by PEACE (as noted in Section I. PUBLIC NOTICE, page 4 of the RFP) for full implementation and evaluation.

4. "Would the department consider given more time to potential new partners to go through the approval process with the PEACE Council and extend its grant application deadline until October 26, 2015?"

Answer: No, the deadline for this RFP is September 25, 2015. This clarification neither 'significantly amends the solicitation' nor does it make 'compliance with the original proposed due date impractical' (Section IV. PROPOSAL PROVISIONS, PRE-PROPOSAL CONFERENCES, page 16 of the RFP).
