	GACS Questions	GBHWC Answers
1.	"Budget Period: 09/30/2018-09/29/2020, with incremental funding (restricted) period(s) from 9/30/2018-9/29/2019 and 9/30/2019-09/29/2020. Please explain what "restricted" period means?"	The "project period" for this grant is for 9/30/18 through 9/29/2023. The term "restricted" in this context means the grant was awarded for two years and funding is "restricted" to the two years specified: Year 1 is 9/30/2018 – 9/29/2019 and Year 2 is 9/30/2019-9/29/2020. Future funding through 9/29/2023 is not a guarantee.
2	"In the proposed template of Strategic Action Plan,, a "cultural Representative" is shown as a "new" key staff position. <b>Is this limited to one "cultural representative"?</b> At GACS, we have a student population which the majority comprises of: 2) Chamorros, and b) Chuukese. We would like to procure an individual that would represent both. "	You may choose to assign the role of "cultural representative" to existing staff or hire one or more new staff as long as each of the four roles are addressed.
3	"With a proposed expansion plan of the current program, could GACS hire additional faculty to teach the program under this grant, keeping the Project Manager in charge?"	The population target is GDOE students in GDOE schools; therefore, GACS' student population is outside the target group for this grant. It would not be possible to hire teachers to work in GACS to expand the current program.
4.	"GACS is expanding the implementation of its curriculum to include all of Middle School students. Do you have curriculum sets readily available for procurement of Grades 6 <sup>th</sup> to 8 <sup>th</sup> for an approximate 234 student population?"	No, GBHWC does not have curriculum sets readily available for procurement for Grades 6 <sup>th</sup> to 8 <sup>th</sup> .
5.	"Is there a limit to the number of partnerships with which GACS can associate under this Grant?"  "Are there any "restrictions" on the kind of services that can be offered?"	There is no limit to the number of partnerships with which GACS can associate with under this grant but such partnerships must address the goals and objectives stated in the RFP and the population target must be GDOE students in GDOE schools.  Please refer to Section III, Scope of Work and Notice of Awards.
