





Section VII Sample contract states:</p> <p><i>"GBHWC agrees: To maintain oversight of the Service Provider's performance in administering the GBHWC residential rehabilitation and social detoxification substance treatment service for adult males."</i></p>	<p>No. 1.</p> <p>The first paragraph of Section VII is incorrect, and it has been revised as stated in Amendment No. 2 attached hereto and posted for public view at www.gbhwc.quam.gov</p>
<p>No. 2. Section III.B, Item 3 Proposed Contents, Requirements and Instructions states:</p> <p><i>"The proposal must include current resumes of treatment staff with experience and expertise in treatment, certification as substance treatment counselors, and must identify a lead current treatment specialist or clinical supervisor that would be responsible for treatment outcomes and contractual performance."</i></p> <p>Please clarify if "certification as substance treatment counselors" is a new requirement under the Hinanao-Ta (Our Journey) Residential Program.</p>	<p>No. 2.</p> <p>Section III.B, Item 3 is incorrect as there should not have included the requirement for a certification as substance treatment counselors as stated in Amendment No. 3 attached hereto and posted for public view at www.gbhwc.quam.gov</p>
<p>No. 3. Section III.B, Item 3 Proposed Contents, Requirements and Instructions states:</p> <p><i>"The proposal must include current resumes of treatment staff with experience and expertise in treatment...:"</i></p> <p>Please clarify if it is required to submit the resumes of care worker (s).</p>	<p>No. 3.</p> <p>Section III.B, Item 3 does require current resumes of the treatment staff which includes the care workers.</p>
