1. Can the RFP be extended a week or so beyond the deadline set for August 21, 2015?

Answer: GBHWC hereby amends page 5 of 51 and 15 of 51 of the RFP to extend the deadline for receipt of proposals to be **not later than 3:00pm, Friday, September 25, 2015, Guam Standard Time**, instead of 3:00pm, Friday, August 21, 2015, Guam Standard Time.

2. Clarification on disclosure affidavit, non-profit organization submitting a proposal: if a staff member who is officially serving as offeror in the bid of the proposal will also be a staff who will be paid to perform work on the implementation/evaluation proposal, does the staff need to be listed and the amount proposed for salary on the project be included in section b of the disclosure affidavit?

Answer: The Offeror of the proposal in response the RFP would be the organization itself as opposed to the "a staff member" of the organization. V. Disclosure Form. "Affidavit Disclosing Ownership and Commission" is a AG Procurement Form 02 (rev. Nov 15 2005) required by 5 GCA Chapter 5, § 5233. Please read the face of the form as to the information requested on the form. Item B. requests, "that persons who have received or entitled to receive a commission, gratuity or other compensation for procuring or assisting in obtaining business related to the bid or proposal for which this affidavit is submitted are as follows [*if none, please so state*]".

Additionally, the above referenced solicitation is hereby amended to extend the deadline to 12:00noon, Guam Time, Monday, September 14, 2015, for all prospective offerors to submit questions regarding the RFP.
