## PURPOSE

The purpose of this policy is to provide an overview of Financial Management System that is used by Guam Behavioral Health & Wellness Center (GBHWC) as a line department of the Government of Guam.

## POLICY

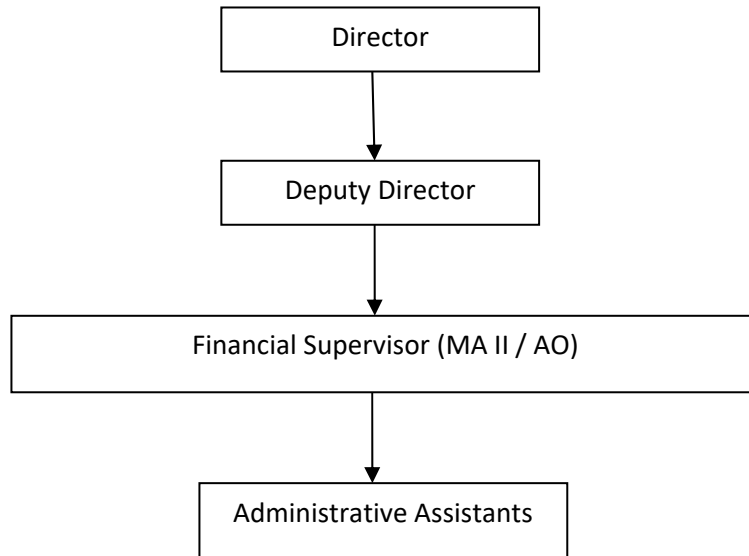
- A. All budgetary and accounting transactions are executed in accordance and guided by the Bureau of Budget and Management Research and the Department of Administration.
- B. The Government of Guam utilizes a central Budget and Accounting Information System (BACIS) which provides budgetary controls over general governmental revenues and expenditures. All line agencies including Guam Behavioral Health and Wellness Center share this accounting information system utilizing the AS400 hardware platform.
- C. In accordance with *5GCA Chapter 22 Article 2, Central Accounting Act*, the Division of Accounts of the Department of Administration is the agency responsible for a uniform financial management system and the related system of internal accounting controls for line agencies of the Government of Guam. DOA utilizes the Budget and Accounting Information System (BACIS) accounting software to process both the budget and accounting transactions.
- D. In accordance with *5GCA, Chapter 4 § 4105 Bureau of Budget and Management Research* (BBMR) is responsible for the uniform budget to include all funds types for all line agencies.

## DEFINITIONS

**AS400:** An accounting information system hardware platform that maintains all accounting records of details as well as summaries of financial transactions.




