Page 19, Section II, K Educational Instruction Outside of Youth's School District, Item 1, 2, and 3 is replaced by the following paragraphs, and shall now read:

- 1. Youth admitted into the TGH who are doing well academically must continue attending their school district for their school instruction.
- 2. A youth not doing well academically due to his/her severe psychiatric condition may be "home schooled" temporarily at TGH provided he/she has an Individual Educational Plan (IEP). The IEP must be initiated or executed prior to the admission into the TGH. This must be a collaborative and coordinated effort of the GBHWC Care Coordinator, the youth's school district administration, and Vendor's Caseworker.
- 3. The Vendor is responsible to arrange for the short-term home school accommodation with the youth's school district and provide the necessary therapeutic supports to prepare the youth to returning back to his/her school district. Vendor must progressively and diligently pursue transition back to the youth's school district.

Except as provided herein, all terms and conditions of the document referenced in the solicitation number above remain unchanged and in full force and effect.
