# PURPOSE:

To provide an overview of the crisis stabilization program description and scope of services that will guide staff in the delivery of such services at the Guam Behavioral Health and Wellness Center (GBHWC). This policy will meet the Commission on Accreditation of Rehabilitation Facilities (CARF) standards section 2A.1, 2A.3 and 2A.9.

### POLICY:

- A. Guam Behavioral Health and Wellness Center (GBHWC) is the sole state entity providing crisis stabilization services to both child and adult population. Crisis Stabilization program is under Nursing Services Division.
- B. The crisis stabilization program provides structured crisis stabilization services in a locked unit that is safe. The unit provides crisis interventions necessary to stabilize and restore the person to a level of functioning requiring a less restrictive level of care. The program capacity are as follow;
  - 1. Adult Inpatient Unit 16 bed capacity
  - 2. Child Inpatient Unit 12 bed capacity
- C. GBHWC's Crisis Stabilization Program shall serve both child and adult consumers' who are experiencing behavioral mental health needs, including alcohol or other drug use and addictions and other psychiatric disorders.
  - 1. Services will be provided in the inpatient settings within the GBHWC main facility 24 hours a day 7 days a week.
  - 2. Crisis Intervention Services at GBHWC is available 24 hours a day, 7 days a week.
- D. The crisis stabilization unit **eligibility criteria** are;
  - 1. Individuals should be 18 years of age or older for the adult outpatient unit and 17 years and younger for the child inpatient unit.
  - 2. The individual is medically stable and free of any severe medical problems needing medical services exceeding GBHWC logistical and human resources. The admitting professional and/or in consultation with CSU staff determines medical need severity. and/or
  - 3. The Individual demonstrates a significant incapacitating or debilitating disturbance in mood/thought/behavior interfering with ADLs to the extent that immediate stabilization is required; and/or
  - 4. The Individual demonstrates active symptomatology consistent with the most current version of DSM diagnosis which requires and can reasonably be expected to respond to intensive, structured intervention within a brief period of time; and/or
  - 5. Individuals are an imminent danger to themselves, danger to others, and/or gravely disabled and/or
  - 6. The Individual requires 24-hour observation and supervision; and

- 7. Clinical evaluation indicates that the individual can be effectively treated with intensive crisis intervention services and returned to a less intensive level of care within a brief time frame.
- E. **Discharge criteria** are met when consumers no longer meets admission criteria and completed the treatment program, or the individual develops a medical condition or has a medical emergency that requires admission to an acute care medical facility, consumer chooses to leave against medical advice, or consent for treatment is withdrawn by the parent/legal guardian of the child and it is determined that the individual has the capacity to make an informed decision and does not meet criteria for an involuntary admission.
- F. Behavioral health services are funded through blended GBHWC funds as determined by appropriations, grants and third-party payers.

### PROGRAM PHILOSOPHY GOALS AND OBJECTIVE

GBHWC's mission is to provide a culturally respectful, quality behavioral health services, that support and strengthen the well-being of the persons served, their families and the community in a safe environment. It envisions a healthy island, committed to promoting and improving the behavioral health and well-being of our community. We are committed to a culture of recovery throughout our systems of care, in our interaction with one another, and with those persons and families who trust us with their care

It is our mission to provide crisis stabilization services in a safe structured setting; restore the person to a level of functioning which requires a less restrictive level of care.

#### DESCRIPTION AND SCOPE OF SERVICES

The Crisis Stabilization Program shall provide screening, assessments, evaluation, treatment (counseling therapy, medication management), program development, suicide prevention activities, /discharge planning as well as appropriate documentation of services. Specific services are delineated in the consumer information brochures.


Services	Scope and Description of Services
Screening & Orientation	An initial process that screen consumers for eligibility to the program, or whether a service can be provided to the consumer based on their needs.
Intake Assessment	For needs related to mental illness includes an evaluation of the life domains of persons served including psychiatric, medical, financial, social, housing, vocational. Assessment instruments include Level 1 Cross-Cutting Symptom Measures and C-SSRS, if applicable.
Psychiatric Assessment and Evaluation	GBHWC psychiatrists are qualified medical doctors who specialize in diagnosing, preventing, treating, rehabilitating mental, behavioral, substance use disorders and physical problems related to psychological issues. Psychiatric care includes an initial psychiatric evaluation, diagnosis, prescription of the treatment plan, and rehabilitation. The treatment plan can include prescription of medications and involvement of an interdisciplinary team of nurses, social workers and psychologists.
