PROJECTS FOR ASSISTANCE IN TRANSITION FROM HOMELESSNESS (PATH) AGREEMENT

I hereby certify that the State/Territory of Guam agrees to the following:

Section 522(a). Amounts received under the PATH Formula Grant Program will be expended solely for making grants to political subdivisions of the State, and to nonprofit private entities (including community-based veterans organizations and other community organizations) for the purpose of providing the services specified in Section 522(b) to individuals who:

- · Are suffering from serious mental illness; or
- · Are suffering from serious mental illness and from a substance use disorder; and
- · Are homeless or at imminent risk of becoming homeless.

Section 522(b). Entities receiving grants under the PATH Formula Grant Program will expend funds for the following services:

- · Outreach;
- · Screening and diagnostic treatment;
- · Habilitation and rehabilitation;
- · Community mental health;
- · Alcohol or drug treatment;
- Staff training, including the training of individuals who work in shelters, mental health clinics, substance abuse programs, and other sites where homeless individuals require services;
- · Case management services, including:
 - Preparing a plan for the provision of community mental health services to the eligible homeless individual involved, and reviewing such plan not less than once every 3 months;
 - Providing assistance in obtaining and coordinating social and maintenance services for the eligible homeless individuals, including services relating to daily living activities, personal financial planning, transportation services, and habilitation and rehabilitation services, prevocational and vocational services, and housing;
 - Providing assistance to the eligible homeless individual in obtaining income support services, including housing assistance, food stamps, and supplemental security income benefits;
 - · Referring the eligible homeless individual for such other services as may be appropriate; and
 - Providing representative payee services in accordance with Section 1631(a) (2) of the Social Security Act if the eligible
 homeless individual is receiving aid under Title XVI of such act and if the applicant is designated by the Secretary to
 provide such services.
- · Supportive and supervisory services in residential settings;
- · Referrals for primary health services, job training, education services and relevant housing services;
- Housing services [subject to Section 522(h)(1)] including:
 - Minor renovation, expansion, and repair of housing;
 - Planning of housing;
 - · Technical assistance in applying for housing assistance;
 - Improving the coordination of housing services;
 - Security deposits;
 - · The costs associated with matching eligible homeless individuals with appropriate housing situations;
 - $\circ~$ One-time rental payments to prevent eviction; and
- Other appropriate services, as determined by the Secretary.

Section 522(c). The State will make grants pursuant to Section 522(a) only to entities that have the capacity to provide, directly through arrangements, the services specified in Section 522(b), including coordinating the provision of services in order to meet the needs of eligible homeless individuals who are both mentally ill and suffering from a substance abuse disorder.

Section 522(d). In making grants to entities pursuant to Section 522(a), the State will give special consideration to entities with a demonstrated effectiveness in serving homeless veterans.

Section 522(e). The state agrees that grants pursuant to Section 522(a) will not be made to any entity that:

- · Has a policy of excluding individuals from mental health services due to the existence or suspicion of a substance use disorder; or
- · Has a policy of excluding individuals from substance use services due to the existence or suspicion of mental illness.

Section 522(f). Not more than four (4) percent of the payments received under the PATH Formula Grant Program will be expended for administrative expenses regarding the payments.

Section 522(h). The State agrees that not more than 20 percent of the payments will be expended for housing services under section 522(b)(10); and the payments will not be expended for the following:

- · To support emergency shelters or construction of housing facilities;
- · For inpatient psychiatric treatment costs or inpatient substance use treatment costs; or
- · To make cash payments to intended recipients of mental health or substance use services.

Section 523(a). The State will make available, directly or through donations from public or private entities, non-Federal contributions toward such costs in an amount that is not less than \$1 for each \$3 of funds provided in such payments. The amount of non-Federal contributions shall be determined in accordance with Section 523(b).

Section 523(c). The State will not require the entities to which grants are provided pursuant to Section 522(a) to provide non-Federal contributions in excess of the non-Federal contributions described in Section 523(a).

Section 526. The State has attached hereto a Statement that does the following:

- Identifies existing programs providing services and housing to eligible homeless individuals and gaps in the delivery systems of such programs;
- · Includes a plan for providing services and housing to eligible homeless individuals, which:
 - · Describes the coordinated and comprehensive means of providing services and housing to homeless individuals; and
 - Includes documentation that suitable housing for eligible homeless individuals will accompany the provision of services to such individuals;
- Describes the source of the non-Federal contributions described in Section 523;
- · Contains assurances that the non-Federal contributions described in Section 523 will be available at the beginning of the grant period;

Section 527(b). Section 528(a). The State will, by January 31, 2026, prepare and submit a report providing such information as is necessary for the following:

- To secure a record and description of the purposes for which amounts received under the PATH Formula Grant Program were expended during fiscal year 2025 and of the recipients of such amounts; and
- To determine whether such amounts were expended in accordance with the provisions of Part C PATH.

Section 528(b). The State further agrees that it will make copies of the reports described in Section 528(a) available for public inspection.

Section 529. Payments may not be made unless the State agreements are made through certification from the chief executive officer of the State.

1. State Summary Narrative

The current PATH provider, Guma' Mami, Inc. (GMI), is a non-profit community-based organization that provides support and services to individuals with disabilities. GMI was found qualified to be the vendor for the Sagan Mami Programs and was awarded an initial contract through the Request for Proposals (RFP) procurement process. This agreement will be for 3 years with GMI receiving \$48,000 from the PATH funds each contract year. GBHWC will receive \$2,000 for administrative costs from the PATH funds annually, as well as provide \$10,170 of in-kind services to the program to assist in program management. The initial contract period was from April 1, 2024 through September 29, 2024. GBHWC requested for an amendment and was approved to extend the expiration date from September 29, 2024 to September 29, 2025. There is a final renewal extension that will cover the period of September 28, 2025 through September 29, 2026. At that point, GBHWC will begin the RFP process for a new contract with an anticipated announcement sometime in May or June of 2026.

Guma' Mami, Inc., main office is located at 117-A Chalan Guma' Yu'us Sinajana Community Complex Room 5, Sinajana, 96910, Guam, while the Drop-In Center is located at 152 W Atty Alberto Lamorena St. Tamuning, GU and will serve the entire island of Guam because of the island's small geographic size. Guma' Mami, Inc. are active members of the Guam Homeless Coalition and participate in outreach efforts and coordinated activities to increase opportunities to reach individuals who are experiencing homelessness and will make necessary referrals for those with serious mental illnesses (SMI)/co-occurring substance use disorders (COD). In FY 2024 a total of 27 individuals were contacted by the PATH program.

In FY 2025 at least 30 eligible individuals experiencing homelessness and 7 literally homeless individuals will be served. PATH funds will be used to continue providing the Drop-In Center component of the **Sagan Mami ("Our Place") Program.** Guma' Mami will work in collaboration with GBHWC's Community Support Services, who will provide case management services; referrals and care coordination by assisting and obtaining of mainstream programs and support services to include facilitation and enrollment process for eligible uninsured clients, work in partnership/referral linkages with Veterans Health Administration and obtain available public health benefits to ensure that other resources are considered first. B. Collaboration with HUD Continuum of Care (CoC) Program:

GBHWC and Guma' Mami, Inc. are active members of the Guam Homeless Coalition-Continuum of Care, comprised of the various unhoused providers. The organization meets monthly and has created a continuum of care plan that addresses the gaps in services for the island's population with people who are unhoused. GBHWC has 3 representatives that attend the monthly coalition meetings. The coalition is administered by the Guam Housing and Urban Renewal Authority and is actively involved in HUD grant funding opportunities.

The Salvation Army is the administrator for HMIS in which they provide training and ongoing training to users, gather data, and formulate reports. Each agency/non-profit organization who has a HMIS End-User Agreement have the ability through their license to enter data in the Coordinated Entry. Catholic Social Services has been identified as the point of contact to monitor data in the Coordinated Entry and ensure that individuals are placed in the appropriate programs. Both GBHWC and Guma' Mami have an identified person to enter data in HMIS.

C. Collaboration with Community Organizations:

The provision of mental health and substance abuse services to individuals who are unhoused are coordinated at the State-level by GBHWC for outreach, case management, counseling, mental health and substance abuse services, residential treatment services, and referral services.

Eligible clients are referred for rehabilitation and sheltered care through low-cost Section 8 housing, public housing, Mainstream Program, NED, Continuum of Care Supportive Housing Programs or to the Residential Recovery Program for individuals, including those who are unhoused with (SMI) and (COD) at the GBHWC. Temporary shelter is also available by non-profit organization, Catholic Social Services, through public health or public housing block grants. The Salvation Army's One-Stop Center for homeless services provides information on available services for Guam's unhoused population. The one-stop center ensures that the continuum of services is operating in a well-coordinated manner and accessible to all individuals who are unhoused. Collaboration will also occur with Department of Integrated Services for Individuals with Disabilities (DISID), Division of Vocational Rehabilitation (DVR) for employment assistance and training.

PATH provider plans monthly outreach activities on their own at various locations around the island and report their outcomes during the monthly GHC-CoC meetings. Through these efforts, they often partner with other providers or referral sources to explore areas that would be possible referrals to the Sagan Mami program.

D. Service Provision:

1. In FY 2025 at least 30 eligible individuals experiencing homelessness will be served. PATH funds will be used to continue providing the Drop-In Center component of the Sagan Mami ("our place") Program. The Sagan Mami Program, Drop-In Center is recognized as a resource in our community to help individuals experiencing homelessness. The center provides a safe place for individuals to be at while obtaining resources and learning skills to improve their well-being. Guma' Mami will work in collaboration with GBHWC's Community Support Services who will provide case management services; referrals and care coordination by assisting and obtaining of mainstream programs and support services to include facilitation and enrollment process for eligible uninsured clients, work in partnership/referral linkages with Veterans Health Administration and obtain available public health benefits to ensure that other resources are considered first. Services to include outreach services; screening; referrals; nutrition materials; community resource center. Sagan Mami documents PATH eligibility through referrals received from GBHWC's Community Support Services which indicates that a client has an SMI/COD and needs assistance. Additionally, Sagan Mami, administers the Vulnerability Index – Service Prioritization Decision Assistance Tool (VI-SPDAT) to guide when housing assistance is needed for Permanent Supportive Housing/Housing First programs. The VI-SPDAT are entered into the coordinated system that is shared among the GHC-CoC.

- 2. Current service system gaps in mental health and other needed services that may be encountered by the PATH-funded organization (non-profit organization): Easily accessible transportation; a temporary shelter for individuals who are unhoused with a SMI/COD will continue to be gaps for the PATH-funded organization; and a clubhouse for adults. The Sagan Mami Programs includes supported employment activities and an enrichment center that incorporates the Substance Abuse and Mental Health Services Administration (SAMHSA) eight dimensions of wellness: physical, emotional, financial, social, spiritual, occupational, intellectual, and environmental.
- 3. The provision of mental health and substance abuse services are coordinated at the State-level by the GBHWC for outreach, case management, counseling, mental health and substance abuse services, residential treatment services, and referral services. The Department of Public Health and Social Services provision for health care through Medicare, Medicaid, and the Medically Indigent Program (MIP), food stamps, general assistance and other generic health and social services. Housing services are coordinated by the Guam Housing and Urban Renewal Agency (GHURA) and the GBHWC. Eligible clients are referred for rehabilitation and sheltered care through low-cost Section 8 housing, public housing, Mainstream Program, NED, and Continuum of Care Supportive Housing Programs. Temporary shelter is also available by non-profit organization Catholic Social Services, through public health or public housing block grants. The Salvation Army's One-Stop Center for homeless services provides information on available services for Guam's unhoused population. The one-stop center ensures that the continuum of services is operating in a well-coordinated manner and accessible to all unhoused individuals. Additionally, collaboration with the Department of Integrated Services for Individuals with Disabilities (DISID), Division of Vocational Rehabilitation (DVR) for employment assistance and training.

GBHWC continues to provide treatment (formerly called Mental Illness and Chemical Abuse - MICA) that serves individuals with a co-occurring illness in different levels of care. Group processes focus on education of substance abuse and mental illness. Components of twelve steps, recovery goals, relapse prevention, stress management, and education on psychotropic medications. Each group member is encouraged to attend selfhelp groups such as Alcoholics Anonymous and Narcotics Anonymous.

GBHWC's Community Support Services provides case management services to individuals with serious mental illness. Services include screening and diagnostic treatment services; planning of housing; costs associated with matching eligible individuals who are unhoused with appropriate housing situations; and assistance in applying and obtaining housing, making referrals and care coordination with primary care health services. Additionally, the role of the social workers with Community Support Services is to continuously engage with the consumer throughout their treatment process.

GBHWC received a funding opportunity for the 2020 Transformation Transfer Initiative (TTI) to improve engagement in outpatient services for young adults experiencing First Episode Psychosis and other serious mental illness including those with co-occurring disorders. GBHWC contracted Guma' Mami, Inc. for the implementation of Project Adilante I Hinemlo (Improving the Wellbeing). Activities include the administration of vouchers, providing supportive contacts, tracking attendance records, and evaluating

data. Guma' Mami, Inc., manages the Sagan Mami programs which consists of four services components for individuals with serious mental illness: Enrichment Center, Supported Employment activities, Peer Support and mentoring, and a Drop-In Center for individuals experiencing homelessness or at eminent risk of homelessness with serious mental illness/co-occurring diagnosis. Guma' Mami Inc., staffing includes individuals with lived experience serving as peer specialists.

E. Data:

GBHWC presently participates in the submission of data to GHC-COC HMIS for its permanent supportive housing program activities. The Salvation Army is the administrator for HMIS in which they provide training and ongoing training to users, gather data, and formulate reports. Each agency/non-profit organization who have a HMIS End-User Agreement have the ability through their license to enter data in the Coordinated Entry. Catholic Social Services has been identified as the point of contact to monitor data in the Coordinated Entry and ensure that individuals are placed in the appropriate programs. Both GBHWC and Guma' Mami have an authorized person to enter data in HMIS. Continued training in HMIS for existing authorized users as well as supporting new staff in using HMIS are coordinated between Salvation Army who is the administrator for HMIS for on-demand training that are conducted one on one with the entity making the request.

F. Housing:

Members of the Sagan Mami Program are provided with information on available housing services. The Sagan Mami participants are referred to the public housing authority and other organizations that provide housing services in which they will be assisted through the process in obtaining housing.

Housing services are coordinated by the Guam Housing and Urban Renewal Agency (GHURA) and GBHWC. Eligible clients are referred for rehabilitation and sheltered care through low-cost Section 8 housing, public housing, Mainstream Program, NED, Housing First, Continuum of Care Supportive Housing Programs or to the Residential Recovery Program for individuals, including those who are unhoused with SMI/COD at the GBHWC.

GBHWC's Community Support Services will be responsible for all documentation for suitable housing for eligible individuals who are unhoused. A gap identified is ongoing care for those who are unhoused or at risk of being unhoused who need caregiving support to live in the community. Currently, Guam lacks resources for caregiving services, however the services that are available are costly and not feasible to this target population. Collaboration with other partner entities will be needed to address this need.

G. Staff Information:

Guma' Mami, Inc. includes a staff with a bachelor's degree in social work and a master's degree in public health administration that serves as the program manager. Staff have participated in the Culturally and Linguistically Appropriate Service (CLAS) training and continue to participate in trainings offered by the Office of Minority Health services in the Department of Public Health and Social Services as well as training from GBHWC.

There are 2 Peer Specialist, one who is certified, and the other staff is in the process of certification.

GBHWC's Community Support Services consists of 17 Social Workers assigned to the Adult Outpatient Services who work collaboratively with 2 Psychiatric Technicians and 2 Community Program Aides to meet the needs of our clients. GBHWC staff also participate in the Culturally and Linguistically Appropriate Service (CLAS) which focuses on Cultural stereotypes, racial myths & misperceptions, ethnic identities and localized examples of discrimination and perception. The training explores the knowledge, beliefs, and attitudes of training participants. The Guam Office of Minority Health CLAS trainings bring focus on the critical need to better serve diverse communities, especially those experiencing health disparities. The goal of this training is to also improve overall customer service delivery for consumers and stakeholders. This training is offered to staff regularly for new hires and continued learning. GBHWC staff are representative of Guam's ethnic and linguistic diversity, diverse religions, gender, age, sexual identity (sexual orientation and gender identity), as well as public and private, military, and non-profit organizations. GBHWC ensures National CLAS standards are met and are incorporated into the day-to-day operations by:

- 1. Provide effective, equitable, understandable, and respectful quality care and services that are responsive to diverse cultural health beliefs and practices, preferred languages, health literacy and other communication needs.
- 2. Advance and sustain organizational governance and leadership that promotes CLAS and health equity through policy, practices, and allocated resources.
- 3. Recruit, promote and support a culturally and linguistically diverse governance, leadership and workforce that are responsive to the population in the service area.
- 4. Educate and train governance, leadership and workforce in culturally and linguistically appropriate policies and procedures on an ongoing basis;
- 5. Establish culturally and linguistically appropriate goals, policies and management accountability, and infuse them throughout the organizations' planning and operations;
- 6. Create a conflict-and-grievance-resolution process that is culturally and linguistically appropriate to identify, prevent, and resolve conflicts or complaints.

These various involvements are planned and coordinated among community partners.

Budget Narrative

PATH funds will be used to continue providing the drop-in center component of the Sagan Mami ("our place") Program. Operational hours are from Monday to Friday from 5:00 PM to 9:00 PM and are closed on holidays and weekends. Each shift consists of one (1) Care Worker and one (1) Peer Specialist.

GBHWC will contract the services of Guma' Mami for the sum of \$48,000 from the PATH funds.

For both the Care Worker (CW) and Peer Specialist's (PS) hours were calculated based on an anticipated number of hours set for the Drop-In Center of 4 hours per weekday. The proposed total wages and benefits for both PS and CW were calculated by the anticipated hours for the year. The provided rates that we follow are dictated by the US Department Labor Service Contract Act for Guam and Northern Marianas.

One (1) CW at .5% of time, scope of work includes assisting the Program Manager with the implementation of Sagan Mami Program activities and services; ensure that the Enrichment Center and Drop-In Center program plans are being followed, ensure quality activities and support for members; provide supervision as necessary; will be responsible for coordinating access to community support services, instruction, and guidance, to name a few.

One (1) PS at .5% of time, scope of work includes providing peer support services to members of the Sagan Mami Program. Under supervision of the Sagan Mami Program Manager, the Peer Specialist will function as a role model to peers; exhibiting competency in personal recovery and use of coping skills; serve as a member advocate, providing consumer information and peer support for members. The PS performs a wide range of tasks to assist peers in regaining independence within the community and mastery over their own recovery process. Recovery resources such as booklets, tapes, pamphlets, and other written materials will be utilized by the Peer Specialist in the provision of services.

B. Collaboration

Guam Behavioral Health and Wellness Center (GBHWC) remains a CARF accredited facility and recently completed our re-accreditation survey in February 2024. GBHWC has attested to be a Certified Community Behavioral Health Clinic (CCBHC) as we continue to move forward in expanding our efforts through systemic changes.

GBHWC has an ongoing collaborative relationship with the Guam Housing and Urban Renewal Authority (GHURA). GHURA was established by Public Law 6-135 on December 18, 1962. GHURA is designated by the Governor of Guam to administer funds received for Guam through the U.S. Department of Housing and Urban Development's (HUD's) various funding programs.

GBHWC as well as many of the island's non-profit organizations and other government entities apply for funding from GHURA for community development, housing vouchers, and other housing programs. GBHWC as well as the PATH provider, Guma Mami, Inc. are active participants in the Guam Homeless Coalition-Continuum of Care and attend monthly meetings as well as Guam Homeless Coalition-Strategic Planning Committee and attend weekly meetings to coordinate services for individuals who unhoused and to address systemic barriers around homelessness.

In 2020, the Governor of Guam signed executive order 2020-03 reconstituting the Interagency Council for Coordinating Homelessness Programs, as well as establishing the Office of Homelessness Assistance and Poverty Prevention (OHAPP) to address the rising concern of homelessness in Guam. In January 2025, the Governor of Guam signed executive order 2025-01establishing the Division of Homelessness Assistance and Poverty Prevention under the Department of Public Health and Social Services as a permanent division emphasizing the commitment to address this social issue systemically and through collaboration among community partners to continue to pursue solutions to assist individuals living without a home or in substandard housing. GBHWC has a representative that is a current officer for the Homeless Coalition who also plays a critical role in the Annual Housing and Homelessness Summit.

Additionally, GBHWC collaborates with other organizations such as the Department of Public Health, Veteran's Administration, WestCare Pacific Islands, Vet Centers to ensure ongoing services and benefits for eligible SMI consumers are received. Department of Corrections and GBHWC works closely in transitioning consumers from the prison system into the community. GBHWC, the court system and DOC are partners in the second chance re-entry grant program for individuals with mental illness including those with co-occurring disorders.

PATH funds will be used for the Sagan Mami program Drop-In Center. Case management services will be provided by the GBHWC social workers and care coordinators which will include assisting our SMI population with accessing and obtaining housing through the various GHURA housing programs under Section 8 such as Housing First, Non-elderly with disabilities, Mainstream, public housing, and other permanent supportive housing programs.

H. Selection of PATH Local-Area Providers

Through a Request for Proposals (RFP) process, the non-profit organization, Guma Mami Inc. (GMI) was found qualified to be the vendor for the Sagan Mami Programs and awarded a contract for an initial term period starting April 1, 2024 through September 29, 2024. An amendment for renewal was approved and the period was extended through September 29, 2025. The final renewal amendment makes the final period September 28, 2025 through September 29, 2026, for a grand total of three years. GBHWC will begin the RFP process in fiscal year 2026 and intends to announce during May or June of 2026, with an anticipated award on or before August of 2026. This agreement will be for 3 years.

The municipalities of Hagatña and Tamuning have been identified by GBHWC as the areas where the greatest concentration of homeless individuals with mental illness are located. However, it should be noted that any individual with lived experience of mental illness in the Guam and is homeless and in need of services will be served at **SAGAN MAMI** regardless of residence on the island, which is geographically small: 32 miles long and 8-12 miles wide.

I. Location of Individuals with Serious Mental Illnesses who are Experiencing Homelessness

The Guam Homeless Coalition-Continuum of Care (GHC-COC) Homeless Point-in-Time (PIT) count was conducted on January 31, 2025, the data is still under review and the report has not been published as of this date. The PIT count is conducted island wide with hundreds of volunteers providing outreach throughout the island to individuals and families living in conditions that meet the category of homeless as defined by U. S. Housing and Urban Development (HUD).

In FY 2024, 27 individuals with SMI experiencing homelessness were served at Sagan Mami during the evening Drop-In Center hours.

On January 26, 2024, the PIT count was conducted which indicated 1,249 homeless individuals surveyed. There were 144 in emergency shelters, 1 in transitional housing and 1,104 unsheltered individuals. Please see the table below. Out of 1,249 individuals surveyed, 844 were reported to be 18 years and older.

It is the intent to address socioeconomic issues within the block grants. The FY 2025-2026 MH Block Grant aims to continue to increase access to services for at least 30 unhoused individuals with SMI and COD adults.

Through local government appropriations, we continue to provide financial support to non-profit organizations that serve individuals who are unhoused with substance use disorders including those individuals with co-occurring disorders. These organizations (The Salvation Army; and Sanctuary, Inc.) provide rehabilitative services to adult males, youth, and adult females respectively.

GBHWC encourages its PATH provider, Guma' Mami, Inc. to participate in the SOAR Training so that participants of the PATH program have access to SSDI benefits. Guam is not eligible for SSI benefits. Currently there is 1 staff member in the PATH program that completed SOAR Training, and 1 staff member is working on his certification. However, the goal is to have all staff under the PATH program to complete this training.

There were 3 individuals who assisted with SOAR in the PATH program. However due to referral process through GBHWC's Community Support Services, these efforts are also coordinated through case management services.

The Guam Department of Public Health and Social Services, through its Division of Senior Citizen program provides annual Medicare training to update service providers relevant Medicare enrollment information.
