### REQUEST FOR PROPOSAL

Professional Services for Criminal Justice Consultation and  
Training Services for Guam's Community Mental Health Centers Grant Program

(GBHWC RFP 2022-03)

Guam Behavioral Health and Wellness Center (GBHWC) is soliciting proposals for professional services from private, public, for-profit or non-profit organizations, companies or individuals interested in providing criminal justice consultation and training services for its Guam's Community Mental Health Centers Grant Program that will establish a comprehensive mental health and substance use services for GBHWC consumers identified as prisoner population at the Department of Corrections (DOC) and incarcerated youth at the Department of Youth Affairs (DYA), who are impacted by the COVID-19 pandemic and effectively address the needs of individuals with serious emotional disturbance (SED), serious mental illness (SMI) and individuals with SED or SMI and substance use disorders, referred to as co-occurring disorder (COD).
