Could you please clarify where they should be placed?"

Answer: As noted in Section XVII. PROPOSAL TEMPLATE, 6. Background Summary and 7. Skill, Experience and Service Delivery (page 45), submit a Needs Assessment Report and Community Action Plan as attachments to this proposal. In the body of your proposal under Section 6. Background Summary, you may indicate the following: Please refer to the Needs Assessment Report attachment. Similarly, in the body of your proposal under Section 7. Skill, Experience and Service Delivery, you may indicate the following: Please refer to the Community Action Plan attachment.

## 2. Is a Guam Business License required?

Answer: As indicated on page 6, Section II. REQUEST FOR PROPOSALS INFORMATION, 'GBHWC is inviting qualified Guam-based non-profit organizations (school, faith, sports, cultural, village, community, civi-based or others)' to respond to this RFP. A non-profit organization may submit a Guam Business License, if applicable. In lieu of a Guam Business License, a non-profit organization may also submit their organization's Certificate of Tax Exemption and/or registration from Guam Department of Revenue and Taxation indicating the organization's status as a non-profit organization. As noted in Section III. BACKRGOUND AND SERVICES REQUIRED, CONTRACTOR QUALIFICATIONS, Page 9, 'GBHWC requires respondents to be legally licensed and/or registered with the Guam Department of Revenue and Taxation to do business on Guam as a non-profit organization'. Section IV. PROPOSAL PROVISIONS, CONTENTS OF THE PROPOSAL, 4. Business License (page 17) is hereby corrected to replace 'on' with 'non' and read 'a. License or registration as a non-profit organization with the Guam Department of Revenue and Taxation'. Section XVII. PROPOSAL TEMPLATE, 4. Business License (Page 45) is hereby corrected to replace 'on' with 'non' and read 'a. License or registration as a non-profit organization with the Guam Department of Revenue and Taxation'.
